- No site inspections are undertaken as part of processing the Land Information Memorandum.
- Current legislation requires Council to issue a LIM within 10 working days.
- However, the Council also offer an urgent service to issue a LIM within 5 working days at a higher cost.
- Issuing of the LIM Report will not occur until payment is received.

Items covered by the Land Information Memorandum

- Known hazards such as flooding, known fill, potential erosion, falling debris etc
- Information on stormwater and sewer services to or within the property
- Information on the availability of water services
- A summary of the rates account
- Council Valuation
- Building/Resource Consents and related information
- Other consents, licenses and certificates
- Requisitions, orders and notices
- Swimming Pool fencing compliance
- District Plan information including zoning and designations
- Information relating to known historic sites or buildings
- Such other information that Council considers may be helpful

- Property Valuation
- To provide assurance to prospective purchasers
- To assure lenders and insurers
