#### 4) PERMIT CONDITIONS

- 4.1 General approval will be given to allow applicants to operate within the South Taranaki District subject to the following conditions:
  - a) Applicants may operate in any area provided that:
    - i) They do not block off entrances;
    - ii) They do not obstruct the footpath and impede pedestrians;
    - iii) That amplification equipment is not used (unless it is a designated open space as defined by Council);
  - b) The applicant must obtain permission from businesses which they are operating outside of;
  - c) The applicant may operate for a maximum of two (2) hours at a time;
  - d) The applicant must not cajole money out of the public;
  - e) The applicant must produce any permit issued to them, when requested to do so by a Police Officer or Authorised Officer; and
  - f) If an applicant is requested by any business operator (of which they are operating outside of), Constable or Authorised Officer to cease and depart, they must do so.
- 4.2 A Busking and Street Activity Permit is only valid for a maximum period of three months.
- 4.3 A Busking and Street Activity Permit is not transferrable.
- 4.4 The Council reserves the right to revoke approval in writing at any time.
- 4.5 Bizlink manages all events and markets conducted in the Hawera Town Square. The applicant must contact Bizlink on 278 4162 if they wish to undertake any busking or street activity in the town square. Please note that if this application is successful, the Council will forward a copy of the application form and issued permit to Bizlink.
