## Wāhanga D – Tauākī/Whakaaetanga Section D - Declaration/Agreement

- a) I agree to abide by the South Taranaki District Council's Trade Waste Bylaws, all the regulations and procedures hereafter lawfully prescribed by the Chief Executive of the South Taranaki District Council and to pay all such fees, rates, and charges to which I will be legally liable.
- b) I confirm that the information given above is true and correct and hereby irrevocably authorise the South Taranaki District Council to obtain information from any source in support of my/our application.
- c) I hereby confirm that I am the owner of the Business/Property mentioned and hereby give permission to the authority to carry out inspections of the trucks on the premises as per trade waste requirements.
- d) I agree to inform the Council immediately if the issued consent is no longer required.
- e) I understand that if requested by the Council: Safety Data Sheets detailing the contents of the waste must be supplied; A complete manifest detailing the waste contents and characteristics of the waste intended to discharge to the Council's wastewater system must be supplied; tests must be carried out to determine the characteristics of the wastes if they are not known and that the costs shall be borne by the consent holder.
- f) I agree not to collect or transport the waste to the disposal site until appropriate arrangements and method of disposal have been determined by the Council; to give 24 hours' notice before disposal of any waste other than those sourced from domestic septic tanks; to log all wastes into the "Waste Track" software system or any other similar system; to pay for the discharge in accordance with consent conditions and applicable trade waste charges.
- g) I understand that any person illegally disposing of, or causing to be disposed, tanker waste either by incorrect disclosure of contents (characteristics and/or amount) or dumping into the Council's wastewater system other than the prescribed location will be in breach of the South Taranaki District Council Trade Waste Bylaw 2017.
- h) I understand that the dumping site is to be left clean after dumping and that access to the dumping site will be revoked if the site is not left clean. I understand that cameras may be installed by the Council to monitor this and that onsite audits of dumping may be carried out by Council employees at the Councils discretion to ensure compliance. I understand that abuse of Council employees will not be tolerated. I understand that an additional clean-up fee may be charged by the Council to rectify any mess left at/on the dumping site.
- i) I understand that the Council reserves the right to revoke/decline or alter any consent.
