### **Explanatory** memorandum

This memorandum is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 12 October 2022, amends the Local Government Members (2022/23) Determination 2022 (the **principal determination**) which covers the period 1 July 2022 to 30 June 2023.

The principal determination contains 2 remuneration schedules. Schedule 1 sets out the remuneration that applied to all local government elected members up until the day on which the official result of the 2022 local election was declared in relation to each local authority. It shows the remuneration of the mayors, regional council chair-persons, councillors who hold positions with additional responsibilities (such as deputy mayor or committee chairperson), councillors with no additional responsibilities, and the minimum allowable remuneration for councillors.

Schedule 2 sets out the remuneration that applies to elected members on and from the day after the date of the declaration of the results of the 2022 local elections. Before the amendment made by this determination, it showed the remuneration of mayors and regional council chairpersons, and the minimum allowable remuneration for a councillor, but did not show the remuneration for positions with additional responsibilities or for councillors with no additional responsibilities. This determination replaces Schedule 2 to include that information for some councils.

Immediately after the local election, each council must submit a proposal to the Remuneration Authority (the **Authority**) on how it wishes to distribute its governance remuneration pool among its councillors. Councils' governance pools are listed in table 2 of the explanatory memorandum appended to the principal determination.

The purpose of the individual governance remuneration pools is to provide those councillors who take on extra duties (such as deputy mayor or committee chairperson) with additional remuneration to that of the base councillor role in recognition of their increased responsibilities.

Explanatory memorandum

Each council's submission to the Authority includes a list of all the positions with additional responsibility that they are establishing for the current triennium, together with a brief description of each role that specifies the additional work and the extra time involved. The submission must propose a remuneration rate for each position with additional responsibilities and a rate for councillors with no additional responsibilities. The council must ensure that its remuneration pool is fully allocated across all its councillor positions.

On receipt of a council's submission, the Authority carefully considers the proposal before determining the remuneration payable to the elected members of the council. This amendment determination implements the Authority's decisions for those councils that have submitted proposals since the day after the date of the declaration of results of the 2022 local election.

The Authority's decisions are backdated as follows:

- the remuneration for councillors with no additional responsibilities takes effect on and from the day after the date on which the official result of the 2022 election of members for the council was declared; and
- the remuneration for positions with additional responsibilities takes effect on and from the day after the date on which the council made its formal decision on its proposed remuneration allocation for submission to the Authority to consider.

In previous determinations, the effective dates were implemented by bringing amendments to individual lines of the relevant schedule into force on different dates, as and when the new remuneration was intended to have effect. This resulted in multiple reprints of the determination as at different dates. New Schedule 2 takes a different approach, in that it indicates in a third column the date on which the remuneration payable in respect of each office is to take effect. This has the same effect as commencing the amendments on different days, but is more accessible for readers and easier to understand.

Councillors will move to their new remuneration in the following sequence. All councillors will receive backdated remuneration at the rate determined for councillors with no additional responsibilities on and from the day after the date on which the official local election results for the council were declared. Then those councillors with additional responsibilities will receive their new remuneration backdated to the day after the date on which the council made its formal decision on the proposed remuneration allocation for submission to the Authority. Those effective dates are set out in the third column of new Schedule 2.

Not all councils were able to submit their proposals to the Authority in time to be considered and included in this amendment determination. A further determination is planned for the first quarter of 2023. It will contain the approved remuneration rates for the remaining councils. In the meantime, the rate of remuneration payable to the mayor, regional council chairperson, and the minimum allowable remuneration for a

councillor, as set out in the principal determination before the replacement of Schedule 2, have been carried forward into new Schedule 2.

Remuneration for mayors, regional council chairpersons, Auckland local board members, and community board members are not included in councils' governance remuneration pools and they are listed separately within *new Schedule 2*. The rates for these members are unchanged from the current version of Schedule 2 of the principal determination.
